NORTH AMERICA

Canada

General

As of May 10th 2022 fully vaccinated pax only need a vax certificate and a completed ArriveCAN travel Declaration. The need to upload a 14-day quarantine plan has been lifted. Non-vaccinated foreigners remain restricted to essential travel only, with two weeks of isolation. There's been no change to crew rules – they must also be vaccinated to enter.

General

CYYZ/Toronto Pearson

Slots for all General Aviation aircraft arrivals and departures and arrivals will be heavily restricted between the hours of 8am-9am and also between 7pm-8pm (local) daily starting 30th May until the 7th of June 7 and from June the 25th until the 30th. Operations during these times is discouraged

USA

KDAL/Dallas Love

The DAL runway 13R/31L will be closed through the end of une 2022 for ongoing runway maintenance. The airport authority has warned operators that due to increased spacing for needed for arrivals, there will likely be very lengthily delays during the afternoon and early evenings when traffic is typically heaviest.

KOSH/Wittman Regional

The annual Oshkosh Airshow will take place on the 25th of July 25 until the 31st. EAA has produced a briefing for pilots attending the large airshow.

For pilots planning on attending it is highly encourage to carefully study the briefing as it includes all the required procedures for operating in and around the airshows airspace.

As is typical for this event, for international GA traffic the US CBP will have customs service at KATW and KGRB but traffic is likely to be heavy so check with local handlers to ensure parking is available

KBOS/Logan International

Beginning the end of May 2022 and extending until June 23rd 2022, all non-scheduled flights will need prior approval to operate at KBOS. This prior approval is due to multiple large events in the area (See KBOS Notam 05/304 for complete details).

The Signature Flight Support FBO has stated that they are allowing operators to make a reservation by emailing them at BOS@signatureflight.com

MEXICO

General

Increased volcanic activity at the Popocatepetl Volcano has resumed and ash cloud as high as 20,000ft have been reported. Mexican ATC have warned that continued eruptions may cause significant disruptions in airport operations and with air traffic at MMMX and MMPB.

ASIA

Hong Kong SAR

General

The Hong Kong SAR government is promulgating a set of fine-tunes arrangements applicable to inbound travelers boarding from overseas and Taiwan and it will come into effect on 1 Jun 2022

1. Inbound pax are only required to present negative result of PCR-based acid test conducted within 48hours without having to present the proof of the ISO 15189 accreditation or recognition by the relevant authority of the government of the place of the laboratory or the healthcare institution.
2. Pre-departure PCR-based nucleic acid tests not required for inbound children aged below 3
3. Pre-departure PCR-based nucleic acid tests not required for travelers transferring or transiting in HK
4. For persons that are recovered persons previously infected with COVID-19, they can be exceptionally allowed to board a flight for Hong Kong if they hold the following documentary proof to show that they were infected with the virus 14 to 90 days prior to boarding for Hong Kong and have recovered, and the result of the rapid antigen test (RAT) conducted within 24 hours prior to boarding was negative.

EUROPE

LSGG/Geneva Switzerland

The 12th World Trade Organization Conference takes place in Geneva from June 12-15. Services are likely to be at a premium, please plan accordingly.

Italy General

Please note that a national 24 hour Strike has been announced on 08 Jun 2022 .This strike will involve various sectors in Aviation both private and public sectors and ATC. Airports involved Milano, Linate, Perugia, Bologna. Possible delays and disruption of services may occur. Operational guaranteed time will be from 0700 to 1000 LT and from 1800 to 2100 LT. Please monitor Notams and CFMU for any updates to the above, as the situation could change with little or no notice.

AFRICA

Rwanda General

CHOGM - Commonwealth Heads of Government Meeting

Rwanda June 20-26th 2022. The Commonwealth Heads of Governments Meeting is taking place in Kigali this June. The event is likely to see thousands of delegates arriving for the event in the Kigali Convention Centre.

As things stand none of the government agencies have published their plans for airfield restrictions, changes in operational procedures or any security issues.

Currently we have been advised that major hotels are sold out of hotel rooms and the smaller hotels are charging in excess of \$500 per night.

Aircraft Parking will be at a premium, remote parking on the opposite side of the live runway is likely to be used. Aircraft may be blocked in requiring the movement of aircraft during the ground time to facilitate departure of aircraft that arrived earlier

Please plan accordingly.

UKRAINIAN SITUATION

A number of Airspace closures are in force, together with restrictions on Russian, owners, operators and registered Aircraft. Russia also has it's own set of reciprocal restrictions. See Notams or the below links for up to date information.
